**SUPERINTENDENT REPORT**

**PTSI Transportation Study-** Draft copies of the Transportation Management Study were provided to each Board Member. David turned the meeting over to Dr. Richard Ahola, Senior management Consultant at Pupil Transportation Safety Institute (PTSI). Dr. Ahola gave a brief background on himself. He informed the Board that he spent many

hours with the HCS transportation department and drove each bus route by car and rode several of the routes on school busses. He reviewed the transportation study with the Board. Dr. Ahola informed the Board that he does not recommend changing to a single bus run at this time as he found no significant savings to the District. He responded to questions from the Board, he also commended the transportation department on their detail to safety, following safety procedures, and their dedication to the students. The Board thanked Dr. Ahola for coming to the Board and the time he put into the study.

**Middle School Band Trip**- David C. Bills turned the meeting over to Brian Wilkins to discuss specifics about the proposed Middle School Band Trip to Cedar Point, OH on May 9 and May 10, 2014.
